- 4) All duties, taxes, royalties, cess, GST, toll taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates prices and total Bid price submitted by the bidder.
- 5) In case of Electrical works the agency should have personnel having **Electrical Contractors license & Supervisory license** of respective **category (1,2,7A, 10 & 11)**.
